Government pushes menstrual health reforms in schools

Delhi Chief Minister Rekha Gupta on Thursday directed Government schools across the capital to improve menstrual hygiene facilities and create a more supportive environment for girl students during a high-level virtual meeting with school principals and education officials on World Menstrual Hygiene Day.

The Chief Minister instructed schools to ensure clean toilets, functioning sanitary pad vending machines, proper medical rooms, and better hygiene facilities for girls. She also stressed the need to make schools emo-

tionally supportive spaces where students can speak openly about menstrual health without hesitation.

Addressing principals and officials through video conferencing from the Jan Seva Sadan, the Chief Minister said menstruation is a natural biological process, and girls should not feel fear, shame, or discomfort while attending school during their periods. She said school authorities have a responsibility that goes beyond administration and includes ensuring emotional support and dignity for students.

The meeting was attended by Education Minister Ashish Sood, Director of Education Vedita Reddy, and senior

department officials. During the discussion, the Chief Minister reviewed menstrual hygiene infrastructure in Government schools and expressed concern over complaints related to dirty toilets and damaged facilities in some institutions.

She directed principals to immediately repair broken doors, improve sanitation, and use available school funds or coordinate with departments concerned to resolve pending issues. She said students cannot be expected to study properly if basic hygiene conditions are neglected.

The Delhi Government also announced several new measures under its "Menstrual



Health Matters" campaign.

A special advisory will be issued for regular maintenance and timely refilling of sanitary pad vending machines installed in schools, government offices, public toilets, and Arogya Mandirs across the city. Officials said

the sanitary pad distribution system will now be centrally monitored to ensure the availability of biodegradable and quality-tested products for girls and women.

The Government will also expand awareness campaigns through ASHA and

Anganwadi workers so that information related to menstrual hygiene reaches households across Delhi. In schools, menstrual health education for students from Classes 6 to 9 will be strengthened as part of the curriculum.

During the meeting, the Chief Minister also spoke about broader women's health issues, including anaemia, PCOS, menopause, cervical cancer, and HPV vaccination. She said regular awareness sessions would be organised at Arogya Mandirs, where doctors and trained healthcare workers would directly interact with women and adolescent girls.

The Chief Minister asked school principals to ensure

that parents are informed about the importance of HPV vaccination and that consent procedures are properly followed. She said awareness about cervical cancer prevention is necessary because the disease affects a large number of women and can largely be prevented through timely vaccination and education.

The Chief Minister also announced that free bicycles would be distributed to girl students after schools reopen. She said parents should also be encouraged to consider HPV vaccination for their daughters during the process.

"A healthy and confident daughter forms the founda-

tion of a strong society," the Chief Minister said during the meeting. She added that Delhi can become a truly developed city only when girls are able to move ahead without fear, stigma, or discomfort.

Education Minister Ashish Sood said menstrual hygiene is not only a health issue but also linked to dignity, confidence, and awareness.

He said schools must become safe and sensitive spaces where students receive proper support and information. Sood said the Delhi Government is committed to ensuring that girls receive clean facilities, access to hygiene products, and timely healthcare support.

Government to roll out hydrogen buses in green transport push

The Delhi Government is preparing to introduce hydrogen fuel cell buses in the national Capital as part of its clean mobility programme, with an initial fleet of two buses to be deployed on a pilot basis in partnership with Delhi Transport Corporation (DTC) and NTPC.

The move marks Delhi's entry into hydrogen-powered public transport and is aimed at strengthening the city's transition towards low-emission and environmentally sustainable mobility systems.

Officials said the buses will operate using hydrogen fuel cell technology, which is known globally for producing zero tailpipe emissions and reducing pollution levels in urban transport networks.

The pilot project will be carried out under a coordinated framework involving DTC, NTPC and other agencies. The Delhi Government said operational arrangements and deployment plans are currently being finalised before the buses begin service in the city.

Delhi Transport Minister Dr Pankaj Kumar Singh said the Government was steadily



arrangements being discussed between the agencies involved. The government said a formal Memorandum of Understanding between the stakeholders is also being prepared to facilitate the launch of operations. Discussions are underway regarding operational procedures, technical support, and route planning for the pilot phase.

Hydrogen fuel cell buses are considered one of the emerging alternatives to conventional fossil fuel vehicles. Unlike diesel-powered buses, hydrogen buses generate electricity through a chemical reaction between hydrogen and oxygen, producing only water vapour as a byproduct. The technology is increasingly being adopted in several countries as governments look for cleaner urban transport solutions.

The Delhi Government said the initiative complements its ongoing efforts to modernise the public transport system and reduce vehicular pollution in the city. The capital has already been expanding its electric bus fleet and promoting clean energy-based mobility solutions in recent years.

Govt mandates IoT-based real-time monitoring system in buildings

The Delhi Government has mandated the installation of an Internet of Things (IoT)-based automated continuous monitoring system (ACMS) in specified buildings to digitally monitor fire prevention and life safety systems in real time by sending alerts through SMS, according to a recent gazette notification.

The new provision, introduced under the Delhi Fire Service (Amendment) Rules,

aims to ensure that both active and passive fire safety measures in buildings remain functional, well-maintained and capable of responding during emergencies.

Under the rules, the ACMS will monitor the operational status of critical firefighting infrastructure, including hydrant pumps, sprinkler systems, fire water tanks, detection systems, manual call points, public address systems, pressurisation fans and basement ventilation systems.

The monitoring system will function through IoT gateways connected to cloud-based servers that will generate real-time alerts and reports for owners, occupiers and empanelled fire safety auditors through mobile applications, emails and SMS alerts.

The implementation of the system will take place in two phases. In the first phase, which comes into effect immediately after the notification of the rules, alerts and system health reports will be accessible to building

owners, occupiers and fire safety auditors.

In the second phase, critical alarms such as pump power failures, low hydrant and sprinkler pressure, and fire alarm faults will also be directly transmitted to the Delhi Fire Service (DFS).

The rules specify that the monitoring system must digitally track key firefighting components such as main hydrant pumps, diesel and electric standby pumps, jockey pumps, booster pumps, underground and overhead fire water tanks,

sprinkler risers and fire alarm control panels.

The system will also monitor operational status of manual call points, public address systems, staircase pressurisation fans, lift lobby pressurisation systems and basement exhaust fans.

According to the notification, the IoT system must use machine-to-machine communication based on MQTTS protocol and support cloud connectivity through 4G, 5G, Ethernet, Wi-Fi or any other reliable wired or wireless medium.
