SOUTH SUDAN

President fires VP Bol

South Sudan's President has dismissed Vice President Benjamin Bol, who had been considered a prospective successor, without explanation after growing concerns about renewed violence in the country. President Salva Kiir's decision to remove Bol was announced in a decree on state television on Wednesday night. Calls to Bol's spokesperson were unanswered. Bol was a close business associate of Kiir and had been sanctioned by the US for corruption.

UK

Delhi blast condemned

Britain's Deputy Prime Minister, David Lammy, and British Indian minister for the Indo-Pacific Seema Malhotra have expressed their condolences to all those impacted by the terrorist attack in Delhi, which claimed 12 lives after a car explosion near Red Fort Metro station. At a special event in honour of the bilateral partnership hosted by the UK's Foreign, Commonwealth and Development (FCDO) in London on Wednesday evening, Lammy described India as one of the UK's most important partners.

Botswana hands over cheetahs to President Murmu

President Droupadi Murmu on Thursday symbolically handed over eight cheetahs by her Botswana counterpart Duma Gideon Boko at a nature reserve near here on the last day of her State visit. The two heads of State reached the Mokolodi Nature Reserve, about 10 kms south of capital Gaborone, earlier in the morning and took a safari vehicle to witness the event of two captured big cats being released into a quarantine pen.

Wildlife officials from India and Botswana also briefed Murmu and Boko about the procedure. Officials said all the eight cheetahs are in the reserve and only two were released for quarantine in the presence of the heads of state as a symbolic gesture of handing over them to India by Botswana.

The cheetahs, a mix of adult and sub-adult males and females, have been brought to the nature reserve from the Ghanzi town located in the Kalahari desert, that forms 70 per cent of the landmass of this southern Africa located country.

The Mokolodi reserve, spread over 3,700 hectares, is a private not-for-profit game reserve that was created in 1994. It is inhabited by rhinoceros, giraffes and a variety of indigenous African bird and reptile species, some of which are rare and vulnerable to the threat of extinction, as per official information.

All eight cheetahs are expected to reach India in the next few weeks after completion of their quarantine process. Murmu is on a three-day state visit to Botswana which concludes on Thursday.

The translocation of the cheetahs from Botswana to India as part of the Project Cheetah was announced by the two presidents on Wednesday during a press briefing after holding delegation level talks at Boko's office.

Murmu thanked the African nation for the endeavour in wildlife conservation and assured that India will take "good care" of the cheetahs. Boko said his country's move to donate the cheetahs will assist regeneration of the population of the big cat in India. India's cheetah re-introduction story began on September 17, 2022 when Prime Minister Narendra Modi released eight cheetahs brought from Namibia into a

special enclosure at Kuno National Park in Madhya Pradesh, marking the world's first intercontinental relocation of a large wild carnivore species.

India later imported 12 more cheetahs from South Africa in February 2023. Three years into the ambitious revival programme, the country now has 27 cheetahs, including 16 born on Indian soil. Of them, 24 are at Kuno and three are at the

Gandhi Sagar Wildlife Sanctuary (GSWS), located on the boundary of Mandasaur and Neemuch districts in Madhya Pradesh. Nineteen cheetahs - nine imported adults and 10 cubs born in India - have died from various causes since the project began, while 26 cubs have been born in Kuno so far. After importing 20 animals from Africa, India currently has a net gain of seven cheetahs over the initial number.

President Trump signs bill ending shutdown

President Donald Trump signed a government funding bill on Wednesday night, ending a record 43-day shutdown that caused financial stress for federal workers who went without paychecks, stranded scores of travellers at airports and generated long lines at some food banks.

The shutdown magnified partisan divisions in Washington as Trump took unprecedented unilateral actions - including cancelling projects and trying to fire federal workers - to

pressure Democrats into relenting on their demands.

The Republican president blamed the situation on Democrats and suggested voters shouldn't reward the party during next year's midterm elections. "So I just want to tell the American people, you should not forget this," Trump said. "When we come up to midterms and other things, don't forget what they've done to our country." The signing ceremony came just hours after the House passed the measure on a mostly party-line vote of 222-209. The Senate had already passed the measure Monday.

G7 diplomats publicly show support for Ukraine

Top diplomats from the Group of Seven industrialized democracies publicly showed their consensus on Ukraine and Sudan on Wednesday, but stayed away from contentious issues like the US Military strikes on boats in the Caribbean and trade.

The foreign ministers of the G7 met with Ukraine's foreign minister on Wednesday as Kyiv tries to fend off Russian aerial attacks that have brought rolling blackouts across the country. Andriy Sybiha said Ukraine needs the support of its partners to survive what will be a "very difficult, very tough winter." "We have to move forward to pressure Russia, to raise the price for the aggression, for Russia, for (Russian President Vladimir) Putin, to end this war," Sybiha said.

The G7 ministers said in a joint statement at the conclusion of the two-day gathering that they are increasing the economic costs to Russia and exploring measures against those who finance Russia's war efforts.

Canada announced more sanctions against Russia, including targeting those involved in the development and deployment of drones, and Britain, a day earlier, pledged money for Ukraine's energy infrastructure.

U.S. Secretary of State Marco Rubio made no immediate announcements about new U.S. Initiatives but said on social media that the meeting delved into ways "to strengthen Ukraine's defense and find an end to this bloody conflict." "We are doing whatever is necessary to support Ukraine," Canadian Foreign Minister Anita Anand said.

Hundreds evacuated after gas leak in Oklahoma

Hundreds of people were evacuated from a city in Oklahoma and others were told to shelter in place after a tanker truck that was leaking in a hotel parking lot spewed a plume of anhydrous ammonia gas, authorities said Thursday. The gas release happened shortly before 10 pm Wednesday. People in the immediate area were in respiratory distress and at least 36 people were taken to a local hospital, city officials said at a news conference. At least 500 to 600 people were in a shelter as of Thursday morning, authorities said. Several nursing homes were evacuated and schools were closed for the day. Authorities said the air quality was being monitored and that the tanker truck was no longer spewing gas. Anhydrous ammonia is used as a fertiliser to help provide nitrogen for corn and wheat plants.
