We are fully aware that compliance with the dematerialization requirement is mandatory, and the company is committed to ensuring timely adherence to all applicable SEBI regulations. The Company has now cleared all outstanding dues related to the SOP fines. Following this, it has initiated the necessary process with the concerned authorities for the unfreezing of the demat accounts of the Promoter and Promoter Group. As of now, some of the PANs associated with the promoters have been unfrozen, and the process of dematerialization is currently underway.</p>
